## CRIME WATCH

### CHERI BETT

**Double parking** - Please make sure that you, your workers, or your guests do not park on the street, adjacent to other vehicles. It is a safety issue, in which emergency vehicles cannot reach residents down street.

**Golf Carts** - Golf carts are not street legal, nor can children under the age of 14 drive them. Please note that parents can be ticketed for this offense.

**Speed Limit** - Crime watch has been asked to remind residents, the speed limit, on the residential streets of Dana Shores, is 20 mph. On Dana Shores Drive the speed limit is 35 mph. It has been noted that there are **residents** driving upwards of 50 mph on the residential streets and even faster on Dana Shores Drive. Should you see such violators please write down the make and model of the car and the tag number then report it to the non-emergency number of the Sherriff's Department (813) 247-8200, As well as Crime Watch so that we may document all incidences for the Sherriff's Office, [cw@dana-shores.com](mailto:cw@dana-shores.com).

**No Wake Zone** - Please remember that ALL of Dana Shores' waterways are a "NO WAKE ZONE" including Versailles parallel to the causeway. A good rule of thumb for our community, if there is a dock or seawall present then it is a no wake zone.

It is always better to keep the neighborhood safe, than to be sorry that your home or someone else's was burglarized.
